**SCENE 1: AUGUST-SEPTEMBER 1940. WARDMAN PARK HOTEL - WASHINGTON, DC**

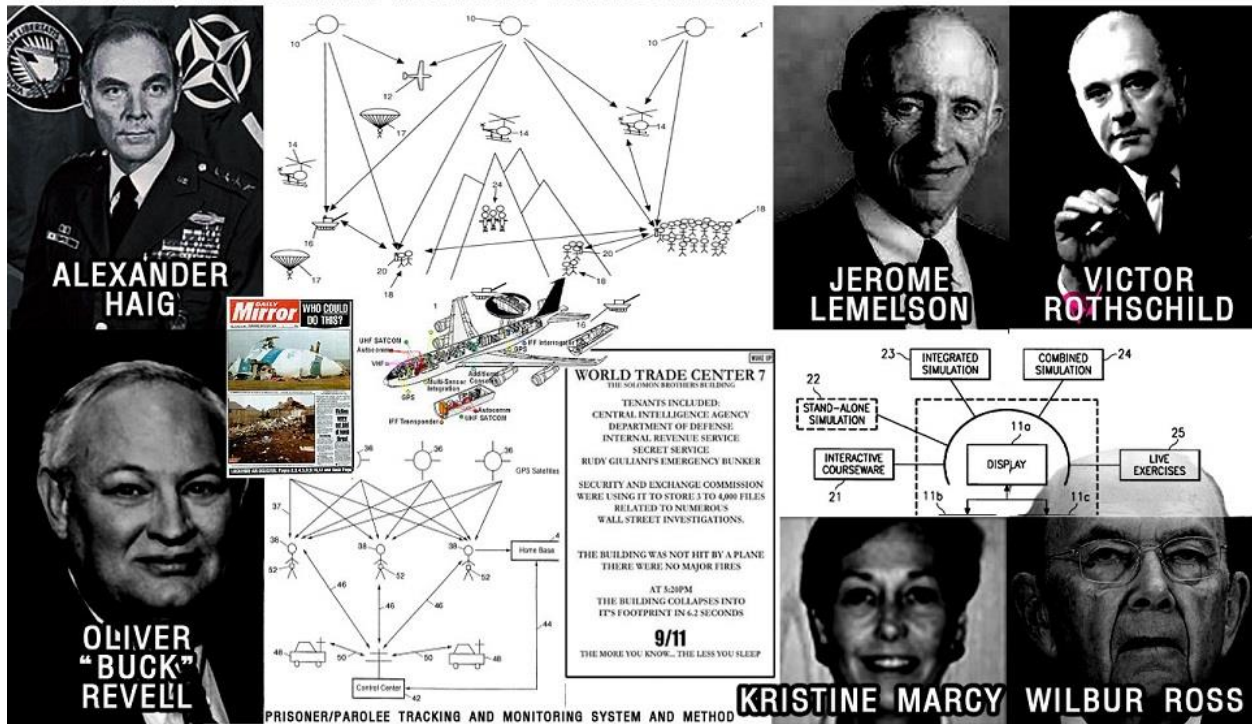
VICTOR ROTHSCHILD PLACES AGENT CYNTHIA IN THE HOTEL TO MONITOR MEETINGS BETWEEN AMERICAN MILITARY OFFICIALS AND A TEAM OF BRITISH SCIENTISTS AND ALLOW N M ROTHSCHILD TO TRADE PATENT RIGHTS FOR INCREASED WARTIME PRODUCTION OF DEVICES SUCH AS THE CAVITY MAGNETRON AND THE PROXIMITY FUZE WHILE WITHHOLDING MILITARY ACCESS TO FRIEND OR FOE IDENTIFICATION TECHNOLOGY AND ENSURE AMERICA CANNOT DEFEND ITSELF AGAINST THE PEARL HARBOR ATTACKS.



*Scene 1: August – September 1940. Wardman Park Hotel in Washington, DC. Victor Rothschild places agent Cynthia in the hotel to monitor meetings between American military officials and a team of British scientists and allow N M Rothschild to trade patent rights for increased wartime production of devices such as the cavity magnetron and the proximity fuze while withholding military access to friend or foe identification technology and ensure America cannot defend itself against the Pearl Harbor attacks.*



**SCENE 2: DECEMBER 1988. 25TH FLOOR OF 7 WORLD TRADE CENTER - LOWER MANHATTAN, NYC**  
 VICTOR ROTHSCHILD (GHOST) AND WILBUR ROSS HIRE INVENTOR JEROME LEMELSON TO STRUCTURE PATENT POOLS OF PRISONER TRACKING AND FRIEND-OR-FOE DEVICES NEEDED BY DEPARTMENT OF DEFENSE (DOD), CENTRAL INTELLIGENCE AGENCY (CIA) AND IRS TO RUN COVERT MISSIONS OUT OF WTC7. KRISTINE MARCY USES 25TH FLOOR TO DEPLOY CON AIR SWAT TEAMS THROUGH GPS DEVICES LINKED TO GEN. HAIG'S AWACS WEAPONS DIRECTORS FOR HVT OR MASS-CASUALTY EVENTS. OLIVER 'BUCK' REVELL REMOVES HIS SON AND DAUGHTER IN LAW BEFORE THEY BOARD PAN AM 103 ON 21 DECEMBER 1988. CON AIR BOMB IS DETONATED THROUGH WTC7 / AWACS LIVE FIRE.



*Scene 2: December 1988. 25th floor of 7 World Trade Center (7 WTC) in Lower Manhattan, New York City. Victor Rothschild (Ghost) and Wilbur Ross pay inventor Jerome Lemelson to structure patent pools of prisoner tracking and friend-or-foe devices needed by The Department of Defense (DOD), the Central Intelligence Agency (CIA) and the IRS to conceal the deployment of Kristine Marcy's Con Air SWAT teams for high-value-target events such as the Alexander Litvinenko murder of 23 November 2006 when a British naturalised former officer of the Russian FSB secret service and expert witness to the Mafia state of organised crime was silence with radioactive polonium or the mass-casualty events such as the Pan Am 103 bombing of 21 December 1988 when four as-yet unnamed government officials died after Oliver 'Buck' Revell removed his son and daughter in law before they boarded the doomed flight.*

**SCENE 3: SEPTEMBER 11, 2001. 47TH FLOOR WTC1 (NORTH TOWER)**

N M ROTHSCHILD'S WILBUR ROSS HOSTS A JUNKET ROOM FOR SERCO SHAREHOLDERS INCLUDING BRITISH AND SAUDI ARABIAN GOVERNMENTS, LINKED TO CIA/DOD/IRS WAR ROOM ON 25TH FLOOR OF WTC7 FOR GLOBAL GUARDIAN EXERCISE. SERCO CEO CHRIS HYMAN ARRIVES AT 8:30 AM FROM BREAKFAST MEETING AT WINDOWS ON THE WORLD RESTAURANT ON 106/107 FLOORS OF WTC1. HE ACTIVATES A PAY-PER-VIEW DEATH-POOL, CHILD-PORNOGRAPHY AND SNUFF-FILM NETWORK CONFISCATED BY THE IRS FROM VANCOUVER-BASED STARNET COMMUNICATIONS IN 1999. FORMER SACEUR GENERAL ALEXANDER HAIG AUTHORIZES AWACS WEAPONS DIRECTORS TO SWITCH AA FLIGHT 11 FROM SIMULATION EXERCISE TO LIVE FIRE AT 8:21 AM (TRANSPONDER OFF). PLANE TAKEN THROUGH DECOY & DRONE MANOEUVRES WHILE HOWARD LUTNICK ASSOCIATES USES A COMBINATION OF PATENTED DEVICE NETWORKS TO DEPLOY MARCY CON AIR SWAT TEAMS FOR CRIME SCENE SCRIPT, SPOT-FIXING, SHOOT, SNUFF, SPIN AND SPOILATION. SCENE ENDS WITH LOCKHEED MISSILE PENETRATOR IMPACT ON NORTH FACE OF NORTH TOWER AT 8:46:46 AM ATTRIBUTED BY HAIG TO "PALESTINIAN OR BIN LADEN GROUPS".



*Scene 3: September 11, 2001. 47th Floor WTC1 (North Tower). N M Rothschild's Wilbur Ross hosts a junket room for Serco shareholders including British and Saudi Arabian governments, linked to CIA/DOD/IRS war room on 25th floor of WTC7 for Global Guardian exercise. Serco CEO Chris Hyman arrives at 8:30 am from breakfast meeting at Windows on the World restaurant on 106/107 floors of WTC1. He activates a pay-per-view death-pool, child-pornography and snuff-film network confiscated by the IRS from Vancouver-based Starnet Communications in 1999. Former SACEUR General Alexander Haig authorizes AWACS weapons directors to switch AA Flight 11 from simulation exercise to live fire at 8:21 am (transponder off). Plane taken through decoy & drone manoeuvres while Howard Lutnick associates uses a combination of patented device networks to deploy Marcy Con Air SWAT teams for crime scene script, spot-fixing, shoot, snuff, spin and spoliation. Scene ends with Lockheed missile penetrator impact on North Face of North Tower at 8:46:46 am attributed by Haig to "Palestinian or Bin Laden Groups".*
