

PROPOSED INVESTIGATIONS AND LEGISLATION

Bi Partisan Congressional Investigation and Public Hearings

Hearings to be aired publicly

Special Prosecutor and Grand Jury

Anybody invoking his Fifth Amendment rights during the Congressional hearings would be put in front of the Grand Jury. The Grand Jury would also subpoena appropriate witnesses. The Grand Jury would return recommendations, findings and indictments.

TRAFFICKING LAWS

Laws to be passed:

1. Any person or entity who uses human trafficking, children, child porn, pedophilia, to compromise, extort or cause another person to do an unwilling act is guilty of a felony with a mandatory 25 year to life in prison, no parole, prison sentence.
2. Any person or entity who buys, sells, trades, or in any way promotes, enables, or profits from human trafficking, pedophilia, human compromise, extortion, or uses children in a criminal manner is guilty of a felony with a mandatory 25 year to life in prison, no parole, prison sentence.
3. Any person, agency, or other entity that interferes, threatens, harasses, impedes, or in any way compromises an investigator, investigation, prosecution, or witness in human trafficking, child porn, pedophilia, or criminal use of children case is guilty of a felony with a mandatory 5 year prison sentence.
4. The use of electronics, social media, or any other form of communications to facilitate, promote, or further human trafficking, child porn, pedophilia, human compromise, extortion, use of children in a criminal manner is a felony with a mandatory fine of one million dollars per incident and a 10 year prison sentence for all parties involved.
5. Any enforcement agency, agent, prosecutor, elected government official, or any other authority that fails to act, with due haste, on human trafficking, pedophilia or the criminal use of children complaint and then doing a complete investigation of the complaint is guilty of a crime. (felony)

As heinous as these crimes of human trafficking, pedophilia, human compromise and sexual exploitation of children are, an overzealous uninformed law enforcement agency, prosecutor, social worker, or mental health expert, who uses less than scientific investigative methods to conduct a “witch hunt,” can wreak havoc on our society and don’t provide any real solutions. There must be an Oversight Committee (see Oversight Committee report) to prevent innocent people from becoming another victim and furthering an already heinous crime.

Upon conviction of either/or #1, #2, #3 and affirmation of the Oversight Committee all assets of the perpetrator(s) or entities involved shall be seized and given to the victim(s).

OVERSIGHT

There must be oversight to prevent innocent people from becoming another victim and furthering an already heinous crime. Upon the conviction of these crimes mandating death or life in prison without parole, the case must be reviewed by an OVERSIGHT COMMITTEE (PANEL). This committee will be made up of 12 members selected in the following manner:

Four members from the general public in good standing, one victim, an ex-prostitute, and a survivor of pedophilia.

Prosecutor selected from an outside jurisdiction.

Public defender from an outside jurisdiction.

Police from an outside jurisdiction.

Mental Health from an outside jurisdiction

Counselor from an outside jurisdiction.

This committee will weigh ALL the evidence, information, testimony, facts, and circumstances. They will have access to all witnesses, prosecutors, public defenders, police, mental health officials, counselors, etc.

The committee will have full subpoena power and follow the mandates of a Grand Jury.

Any person (s), agency(s) who fails to co-operate or testify truthfully will have committed a felony.

Fifth Amendment rights are suspended and immunity is granted. The committee will issue a “statement of fact” confirming the guilt or innocence of the convicted person(s).

MOTHERS AGAINST TRAFFICKING

WHEN THE **MOTHERS** GET TIRED OF THEIR CHILDREN BEING USED AND ABUSED THEY MUST RISE UP AND MAKE THE **FATHERS** DO WHAT IT TAKES TO PROTECT THE CHILDREN

The following steps should be taken to implement a plan of action:

1. An action or plan agreed upon by the Task Force
2. A FEEL-GOOD DO- GOOD approach by reps of the Task Force.
3. If step 2 does not work then the M.A.T. team consisting of 5 Mothers, Nun(s) the Mothers of the Church, and the leader will meet with the parties concerned, outlining our plan or request for action. If necessary, be very demanding.
4. If plan 2&3 fail, notify the phone tree leaders to implement the call plan.

PHONE TREE

1. M.A.T. team requests that the phone tree be activated, with stated information to be conveyed to subject party. Be firm and demanding in the action requested. "NO" is not an option.
2. Phone tree leader is notified, who then alerts 5 tier two phone tree leaders and the electronic communications person(s) to begin the process.
3. These 5 tier two leaders then notify 5 tier three team leaders; this goes on until all members have been notified.
4. If necessary, the phone tree and electronic communication should additionally notify all media outlets, politicians, police, etc.
